MEMBERSHIP CALCULATION EXPLANATION

Member subscriptions are calculated on number of head (x .35c) with a default minimum payment per membership/holding (\$700 +GST) and default maximum per membership entity/company (\$42,000 +GST).

Voting rights are calculated at 1 vote per paid membership holding in the branch to which the membership is affiliated and located.

A membership holding with 2,000 head or less pays minimum per holding of \$700 (+GST).

A membership holding with more than 2,000 head pays .35c per head.

A membership entity/company with more than 120,000 head pays the maximum per membership of \$42,000 (+GST).

Example 1

You have 1 membership holding in the Katherine region with 5,000 head. Your membership identifier/number will start with K. Eg K7.

Your head calculation is 5,000 head x .35c = \$1,500. Subscription = \$1,750 + \$175 (10% GST) = \$1,925 payable

Example 2

I have 2 membership holdings in the Katherine region with 5,000 and 1,000 head. Your membership identifier/number will start with K. Eg K7

Holding1 - Your head calculation is 5,000 head x .35c = \$1,750.

Holding2 - Your head calculation is 1,000 head x .35c = \$350, this is below the minimum payment of \$700 per membership holding so your default for this membership holding is \$700.

Subscription = \$1,750 + \$700 + \$245 (10% GST) = \$2,695 payable

Example 3

I have 3 holdings in Alice Springs and 3 in Tennant Creek with combined 200,000 head. Your member numbers will start with A and TC, e.g. A36 and TC40. Your per head calculation is 200,000 x .35c = \$70,000 which exceeds the maximum payment required.

Subscription = \$42,000 + \$4,200 (10% GST) = \$46,200 payable
